The National Indian Justice Center, Inc., (NIJC) is an Indian owned and operated non-profit corporation with principal offices in Santa Rosa, California. NIJC was established in 1983 to serve as an independent national resource for Native communities and tribal governments.

NIJC designs and delivers legal education, research, and technical assistance programs which seek to improve the quality of life for Native communities and the administration of justice in Indian country. NIJC services may be contracted for local delivery.

Tribal sovereignty may be defined as the right of tribal governments to make their own laws and to be governed by those laws. Tribal governments have fought to protect tribal sovereignty from erosion by state and federal actions, laws and court decisions. Maintenance and expansion of tribal sovereignty requires that tribal government personnel understand the current challenges to the assertion of tribal sovereignty. Recent cases from the Federal courts have directly impacted tribal sovereignty. Tribal sovereign immunity is a key aspect of tribal sovereignty. Tribal sovereign immunity has been challenged in recent federal court cases. This training session will provide information on federal statutes, such as the Tribal Law and Order Act (TLOA) and the Violence Against Women Act Amendments (VAWA), impacting tribal sovereignty as well as federal case law challenging tribal sovereignty and tribal sovereign immunity. We will look at cases such as *Murphy v. Royal*, a case about diminishment of a tribal reservation.

This training session is designed for tribal leadership, tribal government personnel, tribal court judges and administrators, as well as others concerned with the protection of tribal sovereignty. Participants will receive a comprehensive training manual and a certificate of achievement upon completion of the course.
