Additionally, the training provides an introduction to monitoring at road construction, energy development and other public projects to ensure that mitigation measures are implemented and cultural resources are protected. Case examples will be discussed. Participants will receive a comprehensive reference manual and a certificate of achievement upon completion of the course.

As a member of the Native American Advisory Council to the Department of Forestry, he testified before the state legislature and assisted in repatriating the remains of Ishi, the last member of the Yana people. In 1990 he became a member of the California Dept. of Parks and Recreation's Committee to oversee and implement NAGPRA.
