### Tools for Implementing VAWA Provisions

The National Indian Justice Center (NIJC) assists tribes throughout Indian Country in drafting and revising tribal constitutions, and codes. This session examines model codes on subjects, in both criminal and civil jurisdiction. The objective of this session is to provide tribal leaders, judges, attorneys and staff responsible for drafting tribal laws with the tools to increase their equality of self-governance, enhance the efficient operation of tribal government and assure tribal members that their tribal government is responsive and fair. Time will be allocated to address your specific problems and priorities. Bring copies of your code provisions that trouble you. Participants will receive a comprehensive training manual and a certificate of achievement.
