## **About NACTF**

Since 2012, NIJC has received funding from the California Governor's Office of Emergency Services (CalOES) to conduct the Native American Children Training Forum (NACTF).

The purpose of the project is to address the unmet training needs of California tribes and tribal service providers who assist Native American children who are victims of or at risk for child abuse and/or neglect.

## **Project Sites**

Eighteen (18) tribes and community-based organizations participate in NACTF. These sites have received technical assistance to improve their capacity to engage in and/or provide ICWA related distance learning, professional networking and client support services. The trainings and courses offered online are designed for tribal social workers, child welfare workers, social workers, children's services providers, youth advocates, department of justice professionals, law enforcement professionals, elected Tribal officials, Tribal leaders, and all tribal staff or community partners who represent tribal interests in serving Native American children who have been abused/neglected or are at risk.


